3. At the Contract drop down menu select F12/Mobile Services & Devices
4. At the Vendors drop down menu select your vendor of choice; or
5. Click on Results Tabular
6. Price 2 column – click on link to view detailed pricing on services
7. Keyword search: At the top of the page you have the option to type in a keyword search; example: Internet Services (then click on Results Tabular) vendors providing Internet Services will display
